RE: 2024 Gravel Road - Dust Control

If you would like to participate in dust control applications this year, the cost is **\$0.76 per linear foot**. The application is anticipated to occur the second week of June, weather permitting. Dust control updates will be provided on our website [www.LaketownTownship.info](http://www.LaketownTownship.info)

**To participate, your area must be staked and payment received along with the completed form (below) no later than 12:00noon on Monday, June 3rd.** NOTE: If mailing your form and payment, please do so by Friday, May 24<sup>th</sup> to ensure it is received by the deadline. We also have a locked dropbox at the Town Hall located at 9530 Laketown Rd, Waconia, if you prefer to drop it off. Checks should be made out to **Laketown Township**.

Dust control applications treat the gravel roads with a solution that retains water to keep the dust in place and stabilize the road material. Please note the township is not responsible for the effects of rain and every effort is made to schedule the applications when the weather is favorable. The township will continue light maintenance and blading as needed during the summer and fall to fill potholes and washouts that may develop in treated areas.

*Dust Control Application Policy adopted May 7, 2018:*

*The 1<sup>st</sup> application of dust control (magnesium chloride) will be offered to residents at township cost. And, the 2<sup>nd</sup> application (in July) will be paid for by the Township of Laketown, which will be offset by gravel replacement cost savings and less road maintenance. Residents must pay for the 1<sup>st</sup> application to be eligible for the 2<sup>nd</sup> application to paid by the Township.*
